1. Call to Order: R. Hinshaw called the meeting to order at 3:37 p.m.

- 2. Approval of Minutes for November 11, 2011: C. Becker moved to approve minutes and T. Balch seconded. No discussion. Minutes were approved (11-0-1).

- 4. New Business:
 - a) Conceptual Framework

B. Venable moved to approve the proposed Bayh, College of Education Conceptual Framework. The motion was seconded by Y. Park. Members discussed the addition of the UAS paragraph. Inclusion of the paragraph meets NCATE standards. The Conceptual Framework was approved (11-0-1)

b) Program and Course Proposals

Geography Program and Course Proposal

The Earth and Environmental Science Department has proposed to eliminate the *Geography Program for Teacher Licensure* graduate program. C. Becker moved to accept the proposal; T. Balch seconded the motion. Approved (12-0-0)

Health and Safety Program and Course Proposal

The Applied Health Sciences Department has proposed to eliminate the *Health and Safety for Teacher Education* graduate program. C. Becker moved to accept the proposal; T. Balch seconded the motion. Approved (12-0-0)

Family and Consumer Sciences for Teacher Licensure Program and Course Proposal The Applied Health Sciences Department has proposed to eliminate the *Family and Consumer Sciences for Teacher Licensure* graduate program. L. Calvin moved to accept the proposal; R. Hinshaw seconded the motion. Approved (12-0-0)

Health 392 - Educational Methods

The Applied Health Sciences Department has proposed to a change to the Health 392 prerequisites. T. Balch moved to accept the proposal; B. Clauss seconded the motion. After some discussion the motion tabled in order to gather more information concerning the proposed catalog copy.

- c) UAS Committee Updates Steve Gruenert
 - S. Gruenert discussed the following:
 - The term 'assessment' is making its way into program conversations.
 - There have been indicators that the climate of assessment (not the culture) is changing. More faculty are asking how can their work be used in TK20.
 - Assessment Day will be September, 7, 2012. There will be 4 7 activities leading up to it.
- 5. Dean's Report-Brad Balch (REPA 2)
 - a) Looks a lot like REPA 1 and includes all testing areas. The state will be taking comments soon. Dean Balch stated that the future forecast will be to include higher education effectiveness based on new teacher performance from school corporations.
 - b) Communication disorders, school nursing, social work and school psychology have been moved out of the Department of Education.
 - c) Middle school license will change to one content area.
 - d) REPA 2 allows for adjunct teacher permits for candidates with a college degree and 3.0 or above GPA. Candidates can get a permit if the pass the test and this permit is renewable for a lifetime.
 - e) Induction support has been eliminated. It is up to local districts to provide new teacher support.
 - f) The question remains concerning if building administrators have to pass a test.
 - g) REPA 2 opens up teacher preparation to a broad selection of outside agencies.
 - h) NCATE language has been dropped.
