2. Minutes for October 10, 2011 were approved. Motion passed (Becker, Liu, 7-0-1).

3. New Business

- a. Program Proposals
 - EDLR, CIMT, CDCSEP Change in BCOE minimum GPA Policy
 After discussion about the impact of "minus" grades on GPA for students in doctoral programs, the proposal to change our minimum GPA from 3.5 to 3.3 was tabled (Barratt, MacDonald).
 - 2) Congress Policies In an effort to update Congress Policies and make them more understandable, volunteers agreed to edit one section of the handbook. The handbook was divided into 3 sections with the assigned editors and due dates as follows:

4. Old Business

a. Grade Appeal Policy Proposal

J. Powers walked us through the updated proposal and 3 forms that were created to make the Grade Appeal Policy more understandable and more closely aligned with the College of Arts & Sciences policy. Associate Dean Collins suggested that there should be a standing committee ready to convene when an appeal arises. It was noted that the email address needs to be corrected on the contact page. 5. Faculty Senate Representative Report

C. MacDonald reported on the "minus" grading issue. She said there was a lively discussion on the topic at Faculty Senate. Some unintended consequences of the grade change implemented in 2009 are the impact on student GPAs and loss in student retention.

 - Sycamore Educators Day was very successful this year.
 - Dean Balch, D. Quatroche, and S. Kiger are in Washington, D.C. representing ISU at the Teachers for a New Era Conference.

- There will be a teleconference hosted by Dr. Bradley on January 31 on Tenure and Promotion for African-American faculty that will be presented by a nationally known author on the topic.
