EVACUATION

IN THE EVENT IT IS NECESSARY TO EVACUATE THIS FACILITY, THE EVACUATION ROUTES SHALL BE AS FOLLOWS:

ROUTE ONE:

Center stairwell, located on the south side of the elevators, to the ground floor then out the front doors (5th Street side).

ROUTE TWO:

Stairwell on the north side of the building to ground level then out the exterior door. Stairwell on the south side of the building to ground level then out the exterior door.

ROUTE THREE:

Center stairwell to the ground floor then out any door.

ROUTE FOUR:

IMPORTANT: ELEVATORS ARE NOT TO BE USED DURING AN EMERGENCY EVACUATION. OCCUPANTS WILL BE NOTIFIED OF AN EMERGENCY EVACUATION BY PUBLIC SAFETY OFFICERS, THE BUILDING COORDINATOR, OTHER UNIVERSITY OFFICIALS OR ACTIVATION OF THE FIRE ALARM SYSTEM. UPON NOTIFICATION OF AN EMERGENCY EVACUATION, ALL OCCUPANTS WILL LEAVE THE BUILDING AND GATHER AT A DESIGNATED ASSEMBLY POINT.

ASSEMBLY POINTS

DESIGNATED ASSEMBLY POINTS

INFORMATION REGARDING THE DESIGNATED ASSEMBLY POINTS FOR THIS BUILDING SHALL BE POSTED AT OR NEAR EACH BUILDING EXIT.

1. Department of Applied Medicine and Rehabilitation faculty/staff/students are to meet on the north side of Hulman Memorial Student Union near the steps.
2. Student Health Center personnel are to meet on the south side of the Sycamore Center for Wellness & Applied Medicine Building
3. Athletic Training Clinic and Physical Therapy Clinic personnel are to meet in front of the Sycamore Center for Wellness and Applied Medicine Building at the south end to keep the doors clear for emergency personnel
4. Football office personnel are to meet on the south side of the Sycamore Center for Wellness and Applied Medicine by the Sycamore Football sign.

DISABLED SAFE AREAS

IN THE EVENT OCCUPANTS WITH DISABILITIES ARE UNABLE TO EVACUATE THE BUILDING THEY SHALL WAIT FOR ASSISTANCE IN A DESIGNATED SAFE AREA. THESE SAFE AREAS SHALL BE APPROPRIATELY POSTED.

1. Third Floor: North, south, and center stairwell landings.
2. Second Floor: North, south, and center stairwell landings
3. First Floor: Front and Treatment Rooms exits are handicap accessible. Other exits exist by the laboratory to the north, dock door to the east, and end of back hallway to the south. These exits have some type of step(s).
4. Lower Level: Outside patio, north and center stairwell landings.

TORNADO WARNING SAFE AREAS

IN THE EVENT OF A TORNADO WARNING, OCCUPANTS OF THIS FACILITY SHALL BE DIRECTED TO INTERIOR BUILDING LOCATIONS AWAY FROM WINDOWS AND GLASS DOORS.

1. Third Floor: Restrooms and any rooms without windows
2. Second Floor: Restrooms and any rooms without windows
3. First Floor: Restrooms and the following rooms:
 - 104—Front Counter
 - 112 & 113—Treatment Rooms
 - 118—Urgent Care
 - 135 & 138—X-Ray
 - 142—Copier
 - 144 & 145—Exam Rooms
 - 163—Storage Room
 - 167—Break Room
 - 170—FIPSE
 - 172—Nurses Office
 - 177—Storage Room

SPECIAL CONSIDERATIONS

HAZARDOUS MATERIALS

THIS FACILITY CONTAINS THE FOLLOWING HAZARDOUS MATERIALS OR POTENTIALLY HAZARDOUS CONDITIONS WHICH FIRST RESPONDERS SHOULD BE AWARE OF WHEN ENTERING UNDER EMERGENCY CONDITIONS.

SPECIAL CONDITIONS

THE FOLLOWING SPECIAL CONDITIONS EXIST IN THIS BUILDING THAT WILL NEED TO BE ADDRESSED QUICKLY IN THE EVENT OF AN EMERGENCY.

Cadavers—Temperature must not get above 65 degrees—Room 305

NO STUDENT SHOULD BE IN THE BUILDING UNATTENDED BY A PAID SUPERVISOR (COACH, SUPPORT STAFF, FACULTY, STUDENT WORKER) AFTER THE BUILDING CLOSES AT NIGHT AND BEFORE THE DOORS OPEN IN THE MORNING.

BUILDING UTILITIES

FIRE ALARM PANELS

FIRE ALARM PANELS FOR THIS BUILDING CAN BE FOUND AT THE FOLLOWING LOCATIONS.

1. Inside front doors (5th Street side) on the wall to your right.

NATURAL GAS SHUT OFF

Outside east wall of the Sycamore Center for Wellness and Applied Medicine Building.

WATER SHUT OFF

Mechanical room, north wall, lower level of the Sycamore Center for Wellness and Applied Medicine

ELECTRIC SHUT OFF

The main gear for shut off is in the mechanical room, north hall, lower level of the Sycamore Center for Wellness and Applied Medicine.

FIRE PROTECTION WATER CONTROL VALVES

Valves are located outside on the northwest corner of the Sycamore Center for Wellness and Applied Medicine Building. There is no sprinkler system in this building.
