Contracts involving the rental or use of ISU facilities may only be negotiated and signed by those authorized by university policy.

Real estate leases with third parties must be approved by the President and signed by **University Treasurer Diann McKee**.

- Contracts for conferences and special events, including those sponsored by an ISU
 department, are managed through the Division of University Engagement and negotiated
 through Conference and Event Services. Vice President Nancy Rogers is authorized to sign
 these agreements.
- All executed facility use contracts should be submitted to the Office of the General Counsel for report to the Board of Trustees as an informational item at its next scheduled meeting.

FACILITY USE BY EXTERNAL GROUPS

- External groups that wish to reserve any non-athletic space on campus, including classrooms, residential life facilities, or non-athletic recreation spaces, must reserve the space through Conference and Event Services. Conference and Event Services will then coordinate with university departments or colleges. Vice President Nancy Rogers is authorized to sign these use agreements.
- External groups who wish to reserve ISU athletic facilities use should contact the Department of Intercollegiate Athletics. Multi-facility conferences or special events are coordinated through Conference and Event Services. **Athletic Director Sherard Clinkscales** is authorized to sign athletic facility use agreements, except those for multi-facility conferences or special events.
 - Athletic facilities include: ISU Arena, Memorial Stadium, the Rentschler Practice Facility, Sycamore Stadium and Bob Warn Field, Price Field, Gibson Track and Field Complex, and the John McNichols Training Track at Athletic Indoor Facility.

- Rental rates for external use of university facilities are established annually by the President and University Treasurer and published online. A list of non-classroom university facilities is attached to these requirements and may be modified.
- The Office of the General Counsel has issued a standard facility use agreement that is required for all external rental of university facilities. Modifications to the standard agreement other than regular business terms (rate, time available, location, set-up requirements, etc.) must be reviewed and approved by the Office of the General Counsel.

FACILITY USE BY ISU DEPARTMENTS AND STUDENT ORGANIZATIONS

- University departments, employee organizations, or student organizations may reserve classroom space for internal organization or departmental activities by contacting the Registrar's Office.
 University departments or student organizations may reserve classroom space for activities open to the public by contacting Conference and Event Services.
- University departments or student organizations may reserve HMSU meeting rooms by contacting Conference and Event Services.
- University departments or student organizations may reserve the ISU Student Recreation Center (selected spaces), Kennedy Field, Rec East, Wolf Field or the Tennis Courts by contacting Campus Recreation.
- University departments or student organizations who wish to reserve other outdoor or indoor space
 on ISU's campus should contact Conference and Event Services, who will coordinate with university
 departments and colleges.
