 - a. Fall 2014 Fall 2015 enrollment went up by 13%.
 - b. Spring 2015- Spring 2016 enrollment went up by 9%.
 - c. Saudi Arabia and UAE cuts may affect Sponsored student enrollments in the future.
 - d. ISU is leading student enrollment in the State by 12.8%.
 - e. Retention rate within the college is good.
 - f. Unmanned systems and Data Analytics program is going well.
 - g. Six programs went up for ABET accreditation last year. They are AET, MET, PET, Safety Mgt., CET and IT. The team visited in October 2015.
